EXECUTIVE ORDER NO. 164
Series of 2020

**“AN ORDER SHORTENING THE CURFEW HOUR PERIOD IN THE CITY
FROM 10 PM TO 4 AM”**

WHEREAS, on March 08, 2020, the Office of the President Rodrigo Roa Duterte, recognizing that the Corona Virus Disease 2019 (COVID-19) pandemic constitutes a threat to national security, declared A State Of Public Health Emergency Throughout The Philippines through Proclamation No. 922;

WHEREAS, the Inter-Agency Task Force (“IATF”) classified Region X, including the City Government of Cagayan de Oro as low-risk area for COVID-19, and has placed it under modified general community quarantine (“MGCQ”) classification;

WHEREAS, the City Government of Cagayan de Oro has consistently supported the programs of the national government in the fight against COVID-19, and strictly adheres to the various guidelines issued by the IATF governing the adoption of appropriate programs and measures intended to prevent the possible local transmissions of the disease;

WHEREAS, in its calibrated efforts to gradually open the economy in the aftermath of adverse effects of COVID-19 on businesses due to the implementation of strict health regulations and protocols intended to limit the spread of the pandemic, the national government, thru the IATF issued Resolution No. 79, Series of 2020 dated October 15, 2020, which further amended the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as amended;

WHEREAS, due to the decreasing number of Covid cases in the City during the past several weeks, coupled with the need to increase the time in the operation of business establishments to further enhance local economic activities, some of the restrictions need to be adjusted.

NOW, THEREFORE, I, OSCAR S. MORENO, City Mayor of Cagayan de Oro, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. THERE SHALL BE A NEW CURFEW HOUR PERIOD TO BE OBSERVED IN THE CITY.

The curfew hour period in the City shall now commence at ten (10) o'clock in the evening and shall end at four o'clock in the morning of the next day.

SECTION 2. ENFORCEMENT. This Order shall be implemented by the concerned City Government Offices, namely, the Regulatory Compliance Board (RCB), *Disiplina Muna*

SECTION 1. PERSONS NOW ALLOWED TO LEAVE THEIR HOMES FOR NON-ESSENTIAL PURPOSES:

Those who are fifteen (15) years of age and over, and those who are sixty (60) years of age but not over sixty-five (65) years may now go out of their homes for non-essential purposes. They shall also be allowed to enter malls and other business establishments, subject to the strict compliance of the minimum public health standards.

SECTION 2. ENFORCEMENT. This Order shall be implemented by the concerned City Government Offices, namely, the Regulatory Compliance Board (RCB), *Disiplina Muna* Advocacy Team, City Disaster Risk Reduction Management Office, as well as the concerned Barangay Tanods, Cagayan de Oro City Police Office ("COCPO") and the City of Cagayan de Oro Joint Task Force Corona Virus Shield composed of the Philippine National Police, respectively.

SECTION 3. SEPARABILITY CLAUSE. Should any provision of this Order be declared by a court of competent authority as invalid or unconstitutional, the remaining provisions not otherwise adversely affected thereby shall remain in force and effect.

EFFECTIVITY. This Order shall take effect immediately.
